## Mare Breeding Contract • SHIPPED COOLED SEMEN

1. I, \_\_\_\_\_, as owner of the mare \_\_\_\_\_ Registration # \_\_\_\_\_ hereby agree to breed my mare to stallion \_\_\_\_\_ standing at Crescent View Ranch, Arcadia Florida, Registration # \_\_\_\_\_ for the Stallion Service fee of \$\_\_\_\_\_ for a live foal during the \_\_\_\_\_ breeding season.

2. Mare Owner, named above, agrees to pay the Stallion Service Fee for cooled semen from Crescent View Ranch, chute & shipping fees together with other reimbursable expenses. **This includes a \$250 non-refundable booking fee which is payable upon execution of this contract. The balance of the Stallion Service Fee must be paid in full prior to shipment of semen.**

3. The Stallion Service Fee shall include the following:

- a. Breeding Fee
- b. Collection Fee for the first shipment, provided it is made on a regular breeding day (Monday, Wednesday or Friday) and the Stallion Owner is notified prior to 10:00 a.m. Eastern Time on the day semen is shipped. **All Shipping charges, both to receive semen shipment and to return the shipping containers responsibility are the mare owners.**
- c.) First shipment is included in the stallion service fee. Mare owner is responsible for returning shipping containers for the first shipment and any subsequent shipments.

4. Subsequent shipments.

For each additional shipment following the first shipment, the Mare Owner shall be responsible for the following:

- a. \$275 Semen Collection Fee for the next day Federal Express service.
- b. If same day service is necessary, a \$475 fee will include semen collection, courier fee, as well as airline freight charges.
- c. All additional charges and/or unpaid balances shall be automatically billed to your credit card unless otherwise agreed upon in advance by both parties. Charges may include but are not limited to collection fees, off day charges, airport courier fees and airline freight charges.

5. Any shipments requested on Off Breeding Days, including the first shipment, will be charged an additional fee of \$175.

6. **Crescent View Ranch requests that only a LICENSED VETERINARIAN OR TECHNICIAN receive the transported semen, open the container and inseminate the above referenced mare.**

Mare Owner shall attempt with reasonable diligence to settle mare; if however, for any reason the mare does not settle, Mare Owner will hold Stallion Owner and manager harmless.

7. The breeding season for shipped semen is from February 1st to July 1st at which all shipments will be discontinued.

8. If the mare does not settle within the breeding season, the stallion owner will honor the Stallion Service Fee on the mare originally booked (unless otherwise mutually agreed in writing between Mare Owner and Stallion Owner) for the following year only. All rebreeds are subject to a \$600 chute fee.

9. It is agreed that I am guaranteed a live foal at the time of signing of this contract and that if my foal does not stand and nurse, I will be entitled to a free season the following year to the same mare (unless mutually agreed). **THIS GUARANTEE WILL APPLY ONLY IF THE MARE OWNER NOTIFIES CRESCENT VIEW RANCH WITHIN ONE (1) WEEK FROM DEATH; THIS NOTICE MUST BE ACCOMPANIED BY A STATEMENT FROM A LICENSED VETERINARIAN.**

10. Mare owner agrees upon signing this contract, to notify Crescent View Ranch of the pregnancy status of the mare as soon as she is checked, regardless if she is open or pregnant.

11. This contract shall not be transferable by Mare Owner. A breeder's certificate will be issued to the mare owner upon notification of the birth of a foal and only after payment of all bills due on the Mare have been received.

12. The mare owner agrees to send all paperwork to AQHA and Crescent View Ranch.

13. **Is this breeding to be an embryo transfer? YES NO (circle one).**
